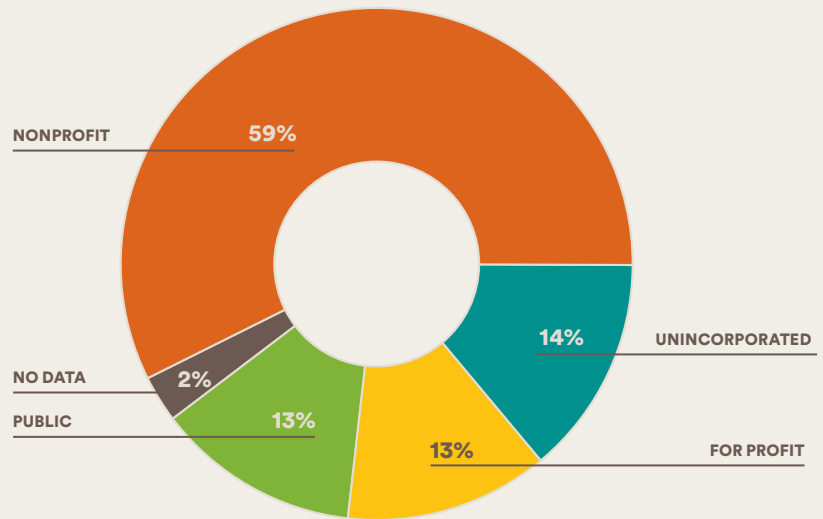

## Glossary of terms:

**GENERATORS:** Set of individuals in 36 cultural occupations (identified by Mass Cultural Council) from American Community Service (ACS) data who make more than half of their income from one of these 36 occupations. Not included in this set of Generators are individuals earning less than half their income from these occupations or working unpaid; individuals working in cultural institutions in other professions (e.g., administrators, educators); and K-12 and college/university teachers in arts, humanities, and sciences.

**MASSACHUSETTS LIVING WAGE:** According to the MIT Living Wage Calculator (<https://livingwage.mit.edu/states/25/locations>) Massachusetts Living Wage of 1 adult with no children is \$58,011 as of December 2024. There is wide variability in the incomes across Generator occupations. Only 8 out of 36 occupations have a median individual income higher than the Massachusetts Living Wage for 1 adult with no children.

**BIPOC:** Black, Indigenous, and People of Color. The data includes the ACS categories of American Indian or Alaska Native, Asian, Black or African American, and Native Hawaiian or Other Pacific Islander and the ACS data category of “Hispanic or Latino.”

**DISABILITIES:** Percent of people as defined by ACS has having “Difficulties” or “cognitive, ambulatory, can’t live independently, can’t self-care, serious vision difficulty interfering with work, serious hearing difficulty interfering with work”.

**OTHER DESIGNERS:** Designers not included in one of the other design related occupations: graphic designers, interior designers, floral designers, web and digital interface designers, commercial and industrial designers, or fashion designers.
