## Work Samples

### Work Sample Upload Instructions

To demonstrate your achievement of creative expression and commitment to your artistic/cultural practice, submit a sample or samples of your creative work. Your work samples should be inprogress or completed within the last five years.

You may submit UP TO FIVE total minutes/pages/image files. This can be all one file type or include a mixture of file types. The important thing is that the total count is at least ONE and no more than FIVE.

You may submit the following file types:

AUDIO: FLAC, MID, MIDI, MP3, RA, RM, WAV, WMA. DOCUMENT: DOC, DOCX, PDF, RTF, TXT. IMAGE: BMP, GIF, JPG, JPEG, or PNG. VIDEO: ASF, AVI, FLV, M4V, MKV, MOV, MP2, MP4, MPEG, MPG, RM, RMVB, WEBM, WMV.

Document files should be no more than 1 MB. Image, audio, or video files should be no more than 1,000 MB/1 GB.

Uploading a media file is a two-step process and larger files may take a long time to complete. First, select the media file from your computer and add it to your application. You will see the media file appear in the Video Library while the system scans it for viruses. If after 10 minutes the system is still scanning the file for viruses, kindly click "Save Draft" to refresh the screen and check if the virus scan has been completed. After the upload and scan are complete, click "Properties" to add your work's Title.

Note: During times when a large number of applicants are in the system, each media file may take 30 minutes or more to upload and scan for viruses. Please plan accordingly and we strongly encourage you to upload your files well in advance of the deadline date.

If you experience an error while uploading your file, try switching to another web browser.

If you are working on the application on or around the deadline, please note that you can still submit your application while the system is scanning your media file for viruses, as long as you have answered all other required information.

## Historically Underfunded: Disability
